**LEGISLATIVE ACTS OF COUNCIL**

**FITNESS CENTER  
 PURCHASE OF EQUIPMENT**

**WHEREAS** two (2) of the three (3) treadmills in the fitness center are not working and the municipality was

unable to purchase the necessary parts to repair them;

**WHEREAS** several frequent users of the fitness center have requested the possibility of purchasing kettlebells and workout ropes;

**THAT** the Municipality of Grosse Ile shall purchase two (2) treadmills (Precor TRM 731 P30), a set of ten (10) kettlebells, four (4) Gymnetic skipping ropes and one (1) Gymnetic workout rope from Body Gym Équipement Inc. for an amount of \$9 473.14, taxes included.

**THAT** an amount of \$8 650.23 be hereby transferred from the accumulated surplus of the Municipality of Grosse Ile in order to cover the cost of the above-mentioned equipment.

**TECQ – GAS TAX PROGRAM 2019-2023**

**WHEREAS** the Municipality has familiarized itself with the Guide regarding the Terms of payment of the government contribution within the Programme de la taxe sur l'essence et de la contribution du Québec (TECQ) for the years 2019 to 2023;

**WHEREAS** the Municipality must respect the terms of this guide in order to receive the governmental contribution that was confirmed in a letter from the Ministry of Municipal Affairs and Housing.

**THAT** the Municipality agrees to be the sole responsible body and releases the Canadian and Quebec Governments, their ministers, administrators, employees and delegates of any responsibility regarding claims for liability, damages, losses or costs of any kind that may be associated with injury or death of any person or for loss or damage to any immovable by a deliberate or negligent act resulting, directly or indirectly, from investments carried out with funds from the TECQ 2019-2023 program;

**THAT** the Municipality approves the content and agrees to send, to the Ministère des Affaires municipales et de l'Habitation, the enclosed work plan number 1, file number 1101042, regarding the aforementioned program as well as any other documentation required by the Ministry in order to receive the governmental contribution that was confirmed by letter from the Ministre des Affaires municipales et de l'Habitation;

**THAT** the Municipality commits to reach the minimum capital threshold imposed on them for the five (5) years of the program;

**THAT** the Municipality agrees to inform the Ministère des Affaires municipales et de l'Habitation of any amendments that may be carried out to the schedule and work plans approved by this present resolution.

**THAT** the Municipality certifies by this present resolution that the enclosed schedule of works number 1, file number 1101042, includes the true incurred costs and reflects the cost estimates of the work which is admissible.

**WIND ENERGY PRODUCTION  
REQUEST TO AMEND THE LAND USE AND  
DEVELOPMENT PLAN OF THE MAGDALEN ISLANDS  
MARITIME COMMUNITY**

**WHEREAS** the Windmill Park of Grosse Ile (S.E.C.) and Hydro Quebec are currently in discussions in order to conclude a contract to purchase electricity (CPE) produced on the territory of the Magdalen Islands by installing four windmills with a capacity of 4,2 MW for a total of 16.8 MW;

**WHEREAS** representatives of the Windmill Park of Grosse Ile (S.E.C.) met with the Municipality in order to present their project and to obtain the council's opinion;

**WHEREAS** the completion of the «Parc de la Dune-du-Nord» project and the two windmills that are in operation have demonstrated that it is possible to install windmills in the dune area while having a low impact on the surrounding environment;

**WHEREAS** the extension of the industrial zone related to the wind energy production towards the East would allow the establishment of the Windmill Park of Grosse Ile, which would be beneficial for the Islands and especially for the community of Grosse Ile;

**WHEREAS** the Zoning Bylaw currently in force within the Municipality's territory does not allow the production of wind energy within the area targeted by the promoters;

**WHEREAS** an amendment as such would not be conform with the major land uses provided for in the Land Use and Development Plan currently in force within the territory of the Maritime Community;

**WHEREAS** the members of council are in favour of this project;
